Wednesday, September 15, 2021, 5:01 p.m. Ocean Breeze Resort Clubhouse, Pineapple Bay Room 700 NE Seabreeze Way, Ocean Breeze, FL

- 1. Call to Order President De Angeles called the meeting to order at 5:01 p.m.
 - Pledge of Allegiance Mayor Ostrand led the Pledge of Allegiance
 - Roll Call Mayor Karen M. Ostrand, President Kenneth De Angeles, Vice-President Richard Gerold, Council Members Kevin Docherty, David Wagner; Late: Council Member Terry Locatis Absent: Council Member Bill Arnold
 - Staff Present Town Management Consultant, Terry O'Neil; Town Financial Consultant, Holly Vath, Town Clerk, Pam Orr; and Bookkeeper/Clerical Assistant, Maria Pierce
- 2. Proposed Millage for Fiscal Year 2021/2022 Holly Vath reviewed the changes from the budget workshop.

President De Angeles asked if the public had any questions or comments.

Michele Gagnon-Dolan, resident of Seawalk asked about the millage rate being lowered to 1.8 mills based on the information provided.

Ms. Vath explained how state shared revenues were calculated as well as how the millage rate was set. She also explained how the millage rate affected the Town reserves.

Ms. Gagnon-Dolan requested that the millage rate be set at 1.3 mills.

Mayor Ostrand suggested that the millage rate be set at 1.2 mills.

Discussion ensued regarding the proposed millage rate and the impact a lower millage rate would have on the reserves, as well as how the reserves were used. Ms. Vath explained the millage rate adoption process.

Ms. Gagnon-Dolan asked how to become a member on the Board.

Mayor Ostrand explained that every year in August, residents could register to run for an elected Council position within the Town. Further discussion ensued regarding the election process.

Ms. Vath estimated that a millage rate of 1.2 would take an extra \$9,500 out of reserves.

Council member Wagner asked if the additional revenues were due to the new permits.

Ms. Vath explained that a small amount of money, about \$20,000 or \$30,000, was from shared State revenues. The other amount of revenue received was from building permits for Seawalk and those revenues could only be used for building permit purposes. She continued that the building permit revenue was not included in the reserve balance.

Discussion ensued regarding various millage rates, ad valorem taxes and reserves.

President De Angeles asked if there were any further comments from Council.

There were none.

Council Member Wagner, seconded by Council Member Docherty, made a Motion to set the tentative millage rate at 1.4.

Roll Call: Yes: Docherty, Locatis, Wagner, De Angeles; No: Gerold; Motion Passed - 4 - 1

Town Management Consultant, Terry O'Neil stated that the Town would prepare a document that would show the effects of the 1.2 millage rate option and how it would affect the reserves for the Final Budget Hearing.

Vice-President Gerold asked if staff would add an option for a 1.0 millage rate.

Discussion ensued regarding Seawalk residents and their property taxes.

Mr. O'Neil explained the breakdown of the total property tax bill and stated that the portion for the Town of Ocean Breeze was very small.

Discussion ensued regarding services the Seawalk residents were receiving.

Town Clerk, Pam Orr, read Resolution No. 315-2021 into the record: A RESOLUTION OF THE TOWN OF OCEAN BREEZE OF MARTIN COUNTY, FLORIDA ADOPTING THE TENTATIVE LEVYING OF AD VALOREM TAXES FOR THE TOWN OF OCEAN BREEZE, MARTIN COUNTY FOR FISCAL YEAR 2021/2022: PROVIDING FOR AN EFFECTIVE DATE.

Council Member Wagner, seconded by Council Member Docherty, made a Motion to adopt Resolution No. 315-2021.

Discussion ensued regarding removal of \$1,000 for election cost since there would not be an election in November 2021.

Town Management Consultant, Terry O'Neil, confirmed that all Council Members present were in agreement to remove the line item of \$1,000 for election cost from the 2021/2022 budget.

President De Angeles asked for comments from the public.

President De Angeles asked for comments from the Council.

Vice-President Gerold stated that at the last Town Council meeting he asked that the Council consider revoting on the Town Hall project.

Discussion ensued regarding the ad valorem tax decrease, state revenue sharing increases, expiration of the fire rescue interlocal agreement, other code compliance increases, feasibility study analysis costs and trash management for Seawalk.

Mayor Ostrand spoke about the importance of conducting a feasibility study for a Town Hall to bring the community together and the proposed location.

Deidre Henry, Ocean Breeze Resort, spoke about the importance of such a study.

Council Member Locatis, seconded by Vice-President Gerold, made a Motion to remove \$5,000 from the budget for the feasibility study.

Ms. Vath stated that if the \$5,000.00 were removed from the budget, the budget would change to \$324,755.00.

Attached are the unaudited financial reports for the 2021 fiscal.

Revenue

The total budgeted revenue was \$284,758, the Town received \$441,897 which is \$157,139 more than budgeted. The majority (\$132,723) is a result of building permit activity. All single family home building permits have been issued for Seawalk. These funds can only be used for expenses related to building permit activities. Several state shared revenues are below budget, however half-cent sales tax exceeded budgetary expectations. The Florida economy continues its strong recovery from COVID restrictions.

Expenditures

The total budgeted expenditures was \$348,010, the Town expended \$275,028. Some categories below budgeted expenditures include the Code of Ordinance update and fewer expenses for code compliance issues. The total net income for the year was \$166,869. A majority of this will be utilized in future years for building permit expenses.

First, allow me to thank you and the Town of Ocean Breeze for the work you all have done to facilitate clean water in our own back yards.

I am on the Treasure Coast Regional League of Cities board with you, and I am the Mayor of the Town of Sewall's Point (Town). Like you and your municipality, our town has been working diligently to establish policies and take actions specific to clean water initiatives.

Our efforts include converting septic tanks to a centralized sewer system, and also capturing stormwater runoff and treating it organically with proper stormwater retention or detention native plantings prior to reintroduction to the environment. The Town believes these efforts support the scientific roadmap to bring the Indian River Lagoon and the St. Lucie River back to good health.

The Town has had some recent victories in these areas. We have completed the connectivity to centralized sewer in the northern part of town, and now look forward to planning the connectivity for South Sewall's Point. The Town also has completed Phase 1 of a four phased approach to a \$20,000,000 resiliency project which includes flood controls and water quality improvements.

We are in need of partners like our neighbor, the Town of Ocean Breeze, to continue our efforts.

The Town has requested financial grant support from the State Legislative Appropriations body in Tallahassee. specifically \$800,000 toward centralized sewer connectivity planning (HB 2123) and \$1,000,000 toward a major stormwater drainage project (HB 2059) to capture stormwater runoff for natural filtration, keeping it (and the toxins) from running directly into the Indian River Lagoon.
