RE: Rescheduling of Town of Ocean Breeze Canvassing Board meeting

After the Town scheduled its post-election Canvassing Board meeting for November 9, 2022, the Martin County Supervisor of Elections advised that, due to the fact that the November 8, 2022 election includes candidates for state and federal offices, it will not be necessary for the Town to convene its own canvassing board, but rather the Supervisor will perform the Town's canvassing function as part of her overall canvassing activities.

Accordingly, the Town of Ocean Breeze Canvassing Board meeting, previously scheduled for November 9, 2022, at 10:00 AM, at the Ocean Breeze Resort Clubhouse, Pineapple Bay Room, 700 NE Seabreeze Way, **has been cancelled.**

Instead, all Town's canvassing board functions will be handled by the Martin County Supervisor of Elections in accordance with the attached schedule of activities.

By copy of this memorandum and through phone calls, all candidates for election to the Town Council have been notified of this change. Further the change has been posted on the Town's web site.
